As the first visiting nurse service in Suffolk County founded in 1952 and the first freestanding inpatient hospice founded in 2004. VNSHS is a trusted leader in healthcare. Healthcare has changed dramatically since we made our first house call nearly 70 years ago. The COVID-19 pandemic has impacted our healthcare system and people's health and way of life as never experienced before.

With meticulous infection control measures, personal protection equipment and ongoing COVID-19 training and testing for our clinicians, VNSHS quickly adapted to serve families facing any healthcare crisis, non-COVID as well as COVID related. There is a shift in the role of home care due to the COVID-19 pandemic. Today, home care is recognized as an essential source of primary care in the community and a resource for education and professional auidance whether for a medical condition or to maintain a healthy life.

VNSHS brings a comprehensive range of services

skilled home nursing, palliative and hospice services • inpatient Hospice House • rehabilitative physical, occupational and speech therapy • wound and ostomy care • home health aide care • medical social work support • nutritional counseling and diabetic education • telehealth • community wellness programs

directly to our patient's homes to address their clinical, educational and psychosocial needs. We provide many services not mandated of home health care or hospice agencies because we know they decrease emergency room visits, hospitalization and readmission, improve medical outcomes and offer peace of mind to our patients and their families.

Upcoming Events

Every patient is offered a Licensed Social Worker (LSW) to provide professional counseling to help them and their families cope with the personal, emotional, financial and social issues that arise from illness or accident, as well as provide guidance applying for Medicaid.

Our **Registered Dietician Nutritionist** (RDN) develops nutritional counseling based on the patient's needs and effectiveness of a medically prescribed diet. Our RDN is also a Certified Diabetes Care and Education Specialist who teaches patients diabetes self-management.

Telehealth allows VNSHS to continuously monitor patient vitals and symptoms which provides patients with a "virtual visit" with a VNSHS clinician so they may monitor and manage their healthcare, safely and easily from the comfort of their own home.

Our Caring Hearts Home Health Aides is a private pay solution offering personal care, meal preparation, light housekeeping, laundry, shopping, home management, companionship, assistance to maintain an exercise program and medication management when these services are no longer or not covered by insurance.

Caring Hearts Aides are VNSHS employees, New York State Certified and supervised by a Registered Nurse.

VNSHS provides a private pay transportation service to and from medical appointments if a patient is not physically able to drive or does not have a caregiver who could do so. This service is provided by a VNSHS Home Health Aide who helps patients prepare for their appointment, assists them to the appointment, waits for them in the waiting room, helps carry bags and provides comforting companionship.



Influenza vaccinations administered by a VNSHS Registered Nurse are available for our homebound patients and members of the community at our Northport office by appointment only. We bill traditional Medicare and traditional Medicaid or provide a receipt for the \$35 fee to submit to private insurance, your HMO or Advantage Plan for reimbursement. Please call 631.261.7200 to schedule your flu shot.

Acupuncture is available to our hospice patients for pain control and symptom management of anxiety, depression, difficulty breathing and swallowing, constipation and diarrhea, dizziness, nausea and

vomiting, neuropathy, paresthesia, contracted limbs and tremors.

For hospice patients who do not meet the criteria for inpatient hospice care, when it is believed that the caregiver would benefit from some rest from the daily care they provide or if they are required to travel, inpatient respite care at Hospice House is available. Medicare insurance covers respite lasting up to five days at a time.



Our VNSHS Bereavement Counselor and specially trained hospice volunteers offer support to those who have experienced the loss of a loved one. This program is currently available by phone and regardless of if a patient was in our care.

Should you or a loved one need home health care or hospice services, VNSHS stands ready to assist. We serve patients throughout Suffolk County in their own home, which may include senior or assisted living facilities. We also provide inpatient care at Hospice House which is available to patients who reside anywhere in the country.

NATIONAL PHYSICAL THERAPY MONTH

October is National Physical Therapy month and an opportunity to raise awareness of how PT can improve and even save lives. VNSHS offers extensive rehabilitative therapy including outpatient physical, occupational and speech therapy reimbursed under the Part B Medicare benefit. The advantage of VNSHS is that our therapy staff will see a patient in their home rather than a clinic or office. Our therapy staff is also trained to assess a patient's vitals to ensure the patient is medically stable to participate in therapeutic activities. The VNSHS therapy team coordinates findings with a patient's physicians should a higher level of care be needed.
